1. Am I reasonably comfortable in a group and able to function as a “team person”?
2. Can I subordinate personal interests for the good of the group?
3. Am I able to express myself with a reasonable amount of clarity in a group situation?
4. Am I able to really hear what others are saying?
5. Can I change my mind on an issue?
6. Can I accept the possibility that others may be better informed on a given issue?
7. Can I accept the fact that the Church is not a democracy and that, for example, the bishop/pastor has the right of veto?
8. Could I uphold the final decision of the board even if I did not personally agree with it?
9. Do I believe in the value of Catholic education as we have it in our diocese/parish today?
10. Would I be willing to accept training, both spiritually and professionally, to become an even better board member?
